

This **OPEN LETTER 2** is created by the ICOM International Committees in response to the messages sent by the ICOM Executive Board, ICOM President and ICOM Director General end June and beginning of July 2020 and submitted to the ICOM leadership.

TO THE PRESIDENT, EXECUTIVE BOARD, AND GENERAL DIRECTOR OF ICOM

In light of the distressing circumstances that have led to the resignation of the ICOM President and other prominent, highly respected members of the ICOM Executive Board and the Standing Committee MDPP2, as manifested by their respective letters of resignation, and in an effort to insure transparency and acquire a better understanding of this situation which is rapidly eroding the trust in the ethical values that this institution upholds, the signatory Chairs of ICOM's International Committees, National Committees, Regional Alliances, Affiliated Organisations and Working Groups, continue to request that the following be shared with us by July 22nd 2020.

- **The minutes** of all meetings of the Executive Board for the years 2019 and 2020, (not a revised re-written report), including the missing minutes for meetings numbers 141, 144, 145 and 146 ¹
- **The minutes** of the procedures behind the appointment of the new president and the disposition in the statutes that regulated the selection.

Once again, we request the minutes, as reasoning for the rendering of reports - in lieu of the original minutes- was obscured under arguments of French laws which were not revealed.

Furthermore, and taking into account the considerations mentioned above, in order to evaluate the working methods of the ICOM Executive Board and ICOM Secretariat, we request:

- **An independent review to be launched to identify and assess shortcomings in internal procedures and communication and suggest remedial improvements to be implemented on the short and longer term.**
- **The full report of the reviewers and the remedial improvements to be shared with the ICOM membership.**

While self-assessment for the EB is a minimum first step, one cannot, at once, be the subject of an audit and be the reviewer. It is for this reason that we ask for an external review to include a committee of experts chosen by NCs, ICs, RAs, AOs and WGs.

We request that this process take place as follows:

1. That the EB self-assessment be shared with us by 23rd July 2020.
2. That:
 - a. the NCs, ICs, RAs, AOs and WGs elect ICOM members to choose and to lead the independent group of reviewers
 - b. access be granted to the elected ICOM members and review team to interview members of the EB and the Secretariat from 2016 until the time of the review, and, to all pertinent documents

- c. a budget be allocated to the group of reviewers, as well as travel expenses, if necessary, for the ICOM members elected by the NC, IC, RA, AOs and WGs to review the shortcomings that led to the resignations.

We request that this proposal be **accepted before July 24th 2020, further to be announced during the General Assembly July 24th**

Budget to be approved by the EB & DG by September 16th 2020, with the review group selected by the elected members of the NCs, ICs, RAs, AOs, WGs and budget submitted to the EB & DG by September 2nd 2020.
